## **JUDGMENTS**

## Australia. High Court

Tabet v Gett [2010] HCA 12 (21 April 2010)

The issue in this case was whether under tort law a person could be compensated for the loss of a chance of a better outcome.

This case involved an alleged delay in diagnosis of a brain tumour in a child who now suffers significant brain damage. On 14 January 1991, Reema Tabet (**Plaintiff**) suffered a seizure, and after a CT scan and EEG were performed, the Plaintiff was diagnosed as suffering a brain tumour. As a result of the brain tumour, the operative procedure and subsequent treatment, the Plaintiff suffered irreversible brain damage (the latter two causes which were not alleged to be negligent). The Plaintiff alleged that if Dr Gett (**Defendant**) had ordered the CT scan to be performed earlier, either on 11 or 13 January, the Plaintiff would have had a chance at a better outcome.




At the initial trial, the trial judge concluded that the Defendant was negligent in not ordering a CT scan on 13 January. This led to the Plaintiff losing a chance of a better medical outcome had the brain tumour been detected on 13 January 1991. The trial judge concluded that the Plaintiff had lost a 40% chance for a better outcome and awarded damages on that basis.

The Court of Appeal dismissed this finding. Whilst it agreed that the Defendant had been negligent in his failure to order a CT scan on 13 January, it concluded on the balance of probabilities the Defendant's negligence did not cause the harm suffered to the Plaintiff, and that damages could not be awarded for the loss of a chance. The Plaintiff appealed the decision to the High Court and sought to reinstate the initial ruling.

The High Court reaffirmed the position that in medical negligence cases, the doctor's negligent act or omission must be proved, on the balance of probabilities, to have caused the harm suffered. It confirmed that compensable loss could not be established by reference to a loss of opportunity.

Accordingly, the High Court dismissed the appeal.
